

Investment objective

The DSC USD Bond Fund follows an active, yield-optimized investment strategy developed by Dreyfus Banquiers. The fund invests primarily in USD investment grade corporate bonds, which are at or below par. In individual cases, the fund can invest in bonds that have a high potential for an investment grade rating upgrade. The fund is broadly diversified. A rigorous risk management process manages interest rate risks. Interest rate derivatives can be used to modify the duration of the portfolio.




