## Investment objective

The DSC Equity Fund investment process identifies defensive, high-quality stocks and combines them with a risk-controlled portfolio. The aim of this two-stage process of equity screening and volatility minimization is to achieve a market-like return in times of rising markets and an excess return in phases of declining markets. Currency risks are partially hedged. This fund invests primarily in equities of manufacturers and dealers of consumer staples and related industries. The fund promotes environmental and/or social characteristics and has therefore been categorised as a financial product in accordance with Article 8 of the Disclosure Regulation (Regulation (EU) 2019/2088).

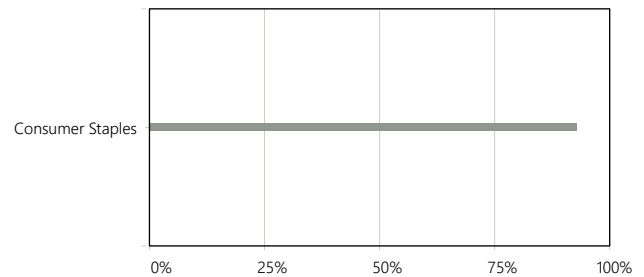

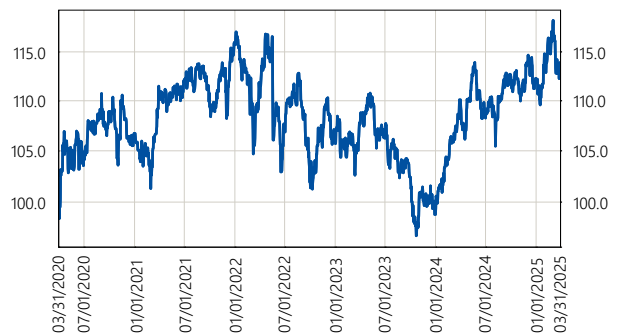
