The aim of this two-stage process of equity screening and volatility minimization is to achieve a market-like return in times of rising markets and an excess return in phases of declining markets. Currency risks are partially hedged. This fund invests primarily in equities of the healthcare sector and related industries.

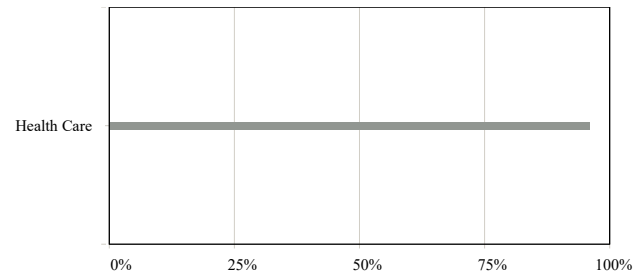

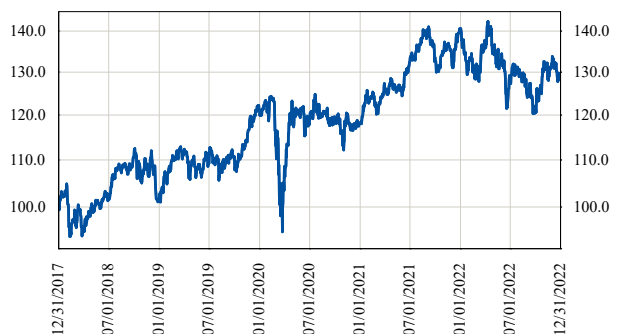
